Manual/Offline bids shall not be accepted under any circumstances.

3. Tenders/bidders are requested to visit website <https://eprocure.gov.in/eprocure/app> regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.

4. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The ICAR-CTCRI reserves the right to accept or reject any or all the tenders.

5. ICAR-CTCRI will not be responsible for any delay in enrolment/registration as bidder of submitting/uploading the offer on-tender portal. Hence, bidders are advised to register in e-tendering website <https://eprocure.gov.in/eprocure/app> and enroll their Digital Signature Certificate and upload their quotation well in advance.

6. Not required to deposit any tender fee.

7. Bidder need not to come at the time of bid opening at ICAR-CTCRI. They can view live bid opening after login on CPPP e Procurement Portal at their remote end. If bidder wants to join bid opening event at ICAR-CTCRI then they have to come with bid acknowledge slip that generates after successfully submission of online bid.

TERMS AND CONDITIONS


- (a) **The Slice/chips making machine for tapioca should be supplied, installed and tested at ICAR-Central Tuber Crops Research Institute, Regional Centre, Dumuduma Housing Board P.O, Bhubaneswar, Odisha-751019.**
- (b) **This Institute is registered with the Department of Scientific and Industrial Research (DSIR) for purpose of availing duty exemption for research purpose in terms of Government Notification No.51/96 -Customs dated 23.07.1996 and Central Excise duty exemption in terms of Government Notification No.10/97-Central Excise dated 1.03.1997 as amended from time to time and entitled for exemption from payment of Excise Duty/ Customs Duty.**
- (c) **Earnest Money Deposited**
An earnest money of **Rs 4000/-** can be submitted in the form of Demand Draft/Bankers Cheque in favour of '**ICAR Unit- CTCRI**' payable at State Bank of India, Kallampally Branch Sreekariyam, Thiruvananthapuram. Name of the Bidder, Tender and Tender reference No. has to be furnished behind the earnest money deposited DD/Bankers Cheque. The scanned copy of earnest money deposited by the way of DD/Banker Cheque or its exemption Certificate in PDF form should be uploaded in the relevant field of the E-Tender. The offers without earnest money deposited will be rejected. **Earnest Money Deposited must be reach physically at the place of opening of the tender on or before 21.11.2020.** Failing which tender will be rejected.
- (d) The earnest money deposited will be returned to the unsuccessful bidders after the orders are placed with the successful bidder
- (e) **BID Validity :** A bid shall remain valid for the period of 90 days from the date of opening tender.

(f) **Performance Security Deposit**

The contractor shall within 21 days from the communication of the acceptance of tender, furnish a Security Deposit at the rate not less than 10% of the total consideration payable under the Contract. The security shall be (i) Bank Guarantee, Demand Draft in favour of the ICAR Unit -CTCRI, Thiruvananthapuram. No other form of receipts shall be accepted. The performance security will be discharged by the purchaser and returned to the supplier on completion of the suppliers' contractual obligations including the warranty obligations under the contract.

- (g) As per the existing rules, no advance payment will be made.
- (h) The bill should have GST number and GST number of ICAR-CTCRI.
- (i) Any loss, damage, pilferage etc. of the material on transit will be sole responsibility of the supplier.
- (j) Supply should be made full against the order and no part supply will be accepted.
- (k) Supply will be completed within the stipulated date of delivery given in the supply order. No extension will be granted except in the case of natural calamity, factory lock out etc. which is beyond the control of supplier. In such cases supplier shall/should approach this office well in advance but not later than the date for consideration towards extension of date of delivery.
- (l) The ICAR-CTCRI reserve the right to reject the stores/work in case these are found not conforming to specification/sample prescribed.
- (m) During evaluation and comparison of bids, the buyer may, at his discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained.
- (n) Any clarification regarding size, specification or printing mistake, if any, can be sought by the bidder before 'Clarification End' date. No request for change in Make/model number/size/ specification etc on any pretext will be entertained post-bid.
- (o) Supply orders are liable for cancellation without assigning any reasons prior to actual supply of stores within the time specified for supply in the supply order.
- (p) The rate should remain valid for three months.
- (q) As per the existing rules, no advance payment will be made.
- (r) The right to accept or reject any or all of the quotation in full or part thereof is reserved by the Director, CTCRI, Thiruvananthapuram.
