- 1.The persons posted to work should attend the work between 9.00 AM to 5.00 PM with one hour lunch break in the afternoon on all working days. In emergent situation, they should also work on holidays.
2. The person deployed shall be required to report for work at 9.00 AM to Farm Section , ICAR-CTCRI, Regional Centre, Bhubaneswar daily and should not leave before 5.00 PM. In case, person deployed is absent on a particular day or comes late/leaves early on three occasions, one-day wage shall be deducted.
3. The persons entrusted with the work should carry out the work without causing any damage to the Institute property and disturbance to the staff members.
4. In case of termination of this contract on its expiry or otherwise, shall not be entitled to and will not have claim or any absorption.
5. If tenderer does not accept the offer, after issue of letter of award by Institute within 15 days, the offer made shall be deemed to be withdrawn without any notice.


