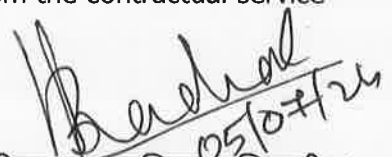
MEMORANDUM

On the recommendation of the Selection Committee, the Competent Authority of ICAR - Central Tuber Crops Research Institute, Sreekariyam, Thiruvananthapuram is pleased to offer to **Ms. Arya A.V., Arya Bhavan, Melekavuvila, Anthiyoor, Balaramapuram P O, PIN: 695501** an appointment to the purely temporary position of **Young Professional I** on Contract basis for Section of Audit & Accounts at ICAR-CTCRI, Thiruvananthapuram on the following terms and conditions:-

- 1 The appointment is purely temporary on contract basis upto 31st March 2025 (likely to be extended) at the rate of monthly emolument at Rs 30,000/- per month (Consolidated). The appointment to the above position will not grant any right for regular appointment against any post at ICAR-CTCRI, Trivandrum or any other benefit of ICAR-CTCRI/ICAR Service.
- 2 On appointment, he/she will draw Rs. 30,000/- per month (Consolidated).
- 3 He/She will be entitled for 8 days casual leave and 2 days RH.
- 4 His/Her Headquarter will be ICAR-Central Tuber Crops Research Institute, Thiruvananthapuram for the present.
- 5 Failure to work to the satisfaction of the Competent Authority, his/her appointment will be terminated without assigning any reasons by one month notice.
- 6 If, he/she leaves his/her duties without permission, he/she will stand terminated from the date of his/her absence and no emoluments due in his/her credit will be paid.
- 7 Either serving by one month notice or depositing one month salary himself/herself, the service of the Young Professional can be discontinued.
- 8 The Young Professional is full time Contractual worker in a purely temporary position and is required to adhere to the administrative, financial and disciplinary regulations of the Institute.
- 9 The Young Professional shall have no legal right to claim his/her regularization/appointment by absorption or otherwise against any regular post or any other contractual engagement on termination of the period. The engagement in the scheme is purely time-bound, non-regular and co-terminus basis. The services of the incumbent shall stand terminated automatically on expiry of the tenure.
- 10 On appointment, he/she will be required to take an oath of allegiance to the Constitution of India or take a Solemn affirmation to that effect in the form enclosed.

- 11 He/She will submit a declaration regarding her marital status in the enclosed form.
- 12 His/Her appointment will be subject to the condition that he/she is declared medically fit for the position of Young Professional by the prescribed **Medical Authority i.e. by Civil Surgeon/Chief Medical Officer (Proforma Enclosed)**
- 13 He/She should produce **a Character Certificate from the head of Educational Institution last attended by him/her or Gazetted Officers and similar certificate from his/her employer, if any, duly attested by I Class executive Magistrate (including a District Magistrate or Sub-Divisional Magistrate (proforma enclosed)**
- 14 He/She will not be entitled for any joining time/travelling allowances for joining the position of Young Professional at ICAR-CTCRI, Thiruvananthapuram.
- 15 He/She shall also execute an undertaking in the enclosed form (Non-judicial stamp paper of Rs.100.00)
- 16 Other conditions of service under the Institute will be governed by the relevant rules and orders which may be issued from time to time by the ICAR in this regard.
- 17 He/She should state whether he/she is serving or is under obligation to serve another Central Govt. Department or a State Govt. or a Public Authority. If he/she is working/serving, he/she should submit the "No Objection Certificate" from his. He/She should also state whether he/she has applied or he/she is being considered for appointment elsewhere.
- 18 In case he/she is pursuing further academic study regularly, he/she cannot be permitted to attend the classes or otherwise for his/her regular academic study
- 19 In case the position is acceptable to him/her on the terms and conditions mentioned above, he/she should intimate his/her acceptance to the undersigned immediately and join duty within 07 days by issue of this memorandum, failing which the order will be cancelled automatically.
- 20 If any declaration given or information furnished is proved to be false or found to have wilfully suppressed any material information, he/she is liable to be removed from the contractual service and any such other action deemed necessary.
