

**Subject : Sealed tender for the disposal of an obsolete/condemned mini Bus for  
Scrap purpose-reg.**

**General Terms and conditions.**

1. The bidders may inspect the mini bus on predetermined dates and satisfy themselves about the mini bus they are bidding for.
2. The mini bus shall be sold to the highest bidder.
3. The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month from the tender opening date, without any interest.
4. The successful bidder will be required to deposit the balance full bid amount by means of Demand Draft/Banker's Cheque from any commercial bank drawn in favour of ICAR Unit-CTCRI payable at Thiruvananthapuram within five working days of the acceptance of the bid, failing which the offer will be cancelled and EMD shall stand forfeited.
5. The successful bidder will have to take delivery of the vehicle within five working days of acceptance of this bid after making the payment of the quoted amount (EMD amount will be adjusted with the quoted value) and submission of affidavit as mentioned in para -6 below, failing which the successfully bidder will forfeit his right over the vehicle and process will be initiated for handing over the vehicle to the second lowest bidder or cancellation of the bid process. In both the events earnest money will be forfeited without any notice in this regard.
6. **An affidavit regarding scraping of vehicle from the First Class Magistrate will have to be given, before taking possession of the vehicle and a letter will be sent to the Transport Authority to cancel the registration of the said vehicle.**
7. The successful bidder will remove the sold vehicle within five working days of depositing the money and submission of affidavit as mentioned in para 6 above, at his or her own expenses. Thereafter, this office will not be responsible for the safety of the vehicle.
8. **The vehicle should be dismantled within 10 days from the date of tender opening and get certified from the jurisdiction RTO. Attested copy of sanction for dismantling the vehicle issued by the RTO will be provided to the successful bidder.**
9. The vehicle will be disposed of on "as is where is basis".
10. The purchaser will be responsible for future legal matters whatsoever, pertaining to the vehicle after taking delivery.
11. The bidder will not be allowed to withdraw their bids, under any circumstances; otherwise, their EMD will be forfeited.
12. All the rights for accept, refusal/rejection or cancellation of this tender shall be reserved with the Director of ICAR-CTCRI, Thiruvananthapuram and his decision will be final binding to all.

13. The Tender should be dropped in the Tender Box of Asst. Administrative Office, ICAR-CTCRI by 13.08.2024 upto 2.30 PM.
14. The financial Bid should be quoted both in figures and words alongwith taxes if any applicable. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the tenderer. Taxes if any shall be borne by the tenderer.
15. The vehicle identification plate(the one that has the engine and chassis numbers engraved on it, successful bidder might need someone to use a blowtorch and cut it out with its surrounding metal) shall be removed and handed over the Competent Authority before taking away the vehicle.
16. Each of tender documents should be signed by the bidder(s).
17. Incomplete and unsigned bids are liable to be rejected.
18. **The bids below the reserved price will not be entertained and liable to be rejected.**
