The tender paper may be obtained from this office during working hours i.e., 10.00 AM to 05.00 PM from 04.05.2024 to 09.05.2024 (02.00 PM) by depositing Rs.500/- in cash or tender form can be downloaded from the ICAR-CTCRI website ([www.ctcri.org](http://www.ctcri.org)) and the filled tender form submitted to the office along with the D.D. for Rs.500/- drawn in favour of the Regional Centre of CTCRI, Bhubaneswar towards the cost of tender form. Last date for receipt of the tenders will be **09.05.2024** (up to 02.00 PM) and the same will be opened at 03.00 PM on the same day. Open auction will be conducted, if the tender price is lower than the reserve price as quoted by any individual or firm.

**TENDER CUM AUCTION NOTICE No.01/2024**

**SUB: DISPOSAL/SALE OF MANGO FRUITS at the Regional Centre of ICAR-CTCRI, Dumuduma, Bhubaneswar through Tender-cum-Auction –reg.**

The Head, Regional Centre of ICAR-CTCRI, Bhubaneswar on behalf of the Indian Council of Agricultural Research, New Delhi invites tender for disposal/sale of mango fruits from around **500 Nos.** of specified mango trees, through tender- Cum-Auction subject to the specified terms & conditions.


**TERMS & CONDITIONS:**

1. Auction of Mango fruits for the specified varieties (Amrapali, Mallika, Banganapalli, Arka Neelachal Keshari, Neelam, Prabha Shankar, etc) only and the total No. of plants are around **500.**
2. The mango fruits to be auctioned may be inspected by the tenderers on any working day between 10.00 A.M. to 5.00 P.M. with the permission of Scientist-in-Charge of this centre to assess the yield of fruits for tender/auction by the tenderer.
3. The tenderer is informed to quote their offer price in the prescribed format only enclosed in **FORM No.1.** The Committee may go for direct bidding among the participants who have submitted their tenders for mangoes auction, if the offered price is not equal to reserve price or more.
4. The tenderer is informed to submit the tender paper signed in all pages about the acceptance of terms and conditions by **2.00 P.M** on or before dated **09.05.2024.** THE TENDERS, WHICH RECEIVED ON TIME, WILL BE OPENED **AT 3.00 PM ON 09.05.2024** at the institute Conference Hall of the institute.
5. After opening the tender papers, if the maximum offered tender does not meet the reserve price, open auction will be adopted among the agencies/individuals, participated in the tender process. **The auction bid is to be held on Dt. 09 /05/2024 at 04.00 P.M. in the conference Hall of office building in presence of the auction committee members.**
6. **Only one authorized person will be allowed to take part in the open auction/tender process.**
7. **MODE OF PAYMENT:**  
**25% of the bid/tender amount has to be paid by the successful tenderer or auctioner on the same day on which tender is accepted and the balance 75% amount within 4 days from the date of auction.** Payment of the 25% and 75% of the amount as required may be made in cash or through e-payment/DD drawn in favour of ICAR-UNIT, CTCRI, Thiruvananthapuram, failing which **0.5% will be charged per day** as penalty on the full amount.



8. **RIGHT TO ACCEPTANCE:** The competent authority reserves its absolute right to accept or reject the whole or part of any tender or portion of the rate quoted. If felt necessary, the rates may be negotiated through auction by the Committee with the tenderers present at the time of opening of tenders.
9. **Agreement & Security Deposit:** The successful tenderer should execute an agreement on a non-judicial stamp paper worth of Rs.100/- and also deposit 3% of the bid amount as security deposit within 4 days from the date of auction. The security deposit amount will be refunded only after the satisfactory completion of the contract, on receipt of written request thereafter.
10. **Watch and Ward:** Watch and ward arrangement should be made by the successful tenderer immediately after the award of contract and the station would not be responsible for the theft and damage by natural calamities or fire etc, thereafter.
11. **Sub tendering of the contract is not allowed.** If found, the agreement will be cancelled and the security deposit will be forfeited.
12. The tenderer or his labourers should not move around the staff quarters **and office premises.**
13. **Harvesting of mango fruits and other activities may be carried out by the tenderer or his labourers between 08.00 AM to 06.00 PM and they have to vacate the campus before 6.00 PM daily.**
14. Storage and ripening activity should not be carried out in the campus.
15. Farm operations will be continued and the contractor will have no right to interfere with the regular farm operations.
16. The successful tenderer on receipt of work order from the Head and deposit of full auction amount, shall be entitled to enter into the specified area for harvesting of mango fruits.
17. **The successful tenderer must submit the name and details of required personnel with their identity to be engaged in collection of mango fruits inside the campus. Only those authorized personnel will be allowed inside the campus.**
18. He shall have no right on the land, other trees, permanent structures and on other assets of the Regional Centre of ICAR-CTCRI inside the plantation during the period of such temporary possession excepting the right for harvest of mango fruits.
19. Any loss, damage or pilferage of other property including plantation caused by him or his workers shall be personal responsibility of the tenderer/contractor, which will be recovered outright.
20. The Regional Centre of ICAR-CTCRI/Council shall not be held responsible for any damage and or loss due to any climatic hazard, fire hazard or any natural calamity during the contract period and the tenderer will be debarred from claiming refund of any amount, either in full or in part on these accounts.
21. He shall be personally liable to compensate the loss or damage if any caused to other trees, the land or any other assets of the centre inside the plantation during harvesting of mango fruits within the contract period as would be assessed by the Head, Regional Centre of ICAR-CTCRI and the same may be deducted from the refundable security deposit of the contractor.
22. The Regional Centre of CTCRI/Council official and staff shall have the right to go round the plantation to inspect the same and carry on such cultural operations as may be considered necessary by them or take observations during the contract period.
23. The Regional Centre of ICAR-CTCRI shall not bear any responsibility legally or otherwise for breach of peace, litigation or any public vandalism inside the plantation, if occurs or during the course of harvesting of mango fruits within the tender period.

24. At the same time, Regional Centre of ICAR-CTCRI will take appropriate action if peace and discipline of the campus are broken by the tenderer at any point of time during the auction period.
25. The responsibility of harvesting of fruits rests with the tenderer without any damage to the trees at their own cost and remove with their own means.
26. **The tender period will end by 30<sup>th</sup> June, 2024** however, if required this may be extended with prior approval of Head, Regional Centre ICAR-CTCRI. The tenderer and his personnel will leave the campus as soon as the tender period is over, but not beyond **30.06.2024**.
27. **They should not carry any prohibited items into the campus and should not indulge unlawful activities** and the labourers engaged for packing mango fruits should not be intoxicated condition within the campus.
28. In case of unavoidable circumstances viz., declared holidays, bandh etc., the specified dates for various steps may be extended to the next working day for which notice will be displayed only at our office premises.
29. The produce except those auctioned, will not be allowed to be removed. In the case the highest bidder or his persons is found doing so the contract will be nullified and the money deposited for the purpose will be forfeited.
30. Firewood should not be used for cooking etc. in the orchard. If he and his persons are found doing so the contractor will have to pay the penalty fixed by the Head, Regional Centre of ICAR-CTCRI, Bhubaneswar.
31. If any accident occurs due to the negligence of the contractor or his personnel, he/she will have to pay the damage cost fixed by the Head, Regional Centre of ICAR-CTCRI, Bhubaneswar.
32. Any tax, if leviable, shall have to be paid by the successful bidder.
33. **Arbitration:** In the event of any dispute of differences arising in connection with the tender, the same shall be referred to the Director, ICAR- Central Tuber Crops Research Institute, Thiruvananthapuram. The decision of the Director shall be final and should be found by both the parties.
34. Notwithstanding the above, the undersigned reserves the right to accept or cancel all tenders at any time prior to award of the contract, without assigning any reason, whatsoever and without incurring any liability of obligation, whatsoever, to the affected tenderer.
